## 2. REPORT: OPSRRA AGM AND CONSTITUTION CHANGES

### Annual General Meeting

OPSRRA held its twenty-second AGM on March 22, 2014.

Resolution: To change OPSRRA name.

- The Society name is OPSRRA: Passed

The Society represents residents and ratepayers who reside in the communities of Otter Point, Shirley and Jordan River and who are members of OPSRRA.

The change will come into effect once approved by the provincial Registrar of Companies.

Other changes which were unanimously approved at the AGM included:

**President's Report: Summary of OPSRRA Activities since March 2013 AGM**

1. OPSRRA directors held 9 monthly directors' meetings.
2. 11 monthly newsletters were sent to about 300 members and 25 non-members on e-mail.
3. Continued to up-date the OPSRRA web page ([www.opsrra.ca](http://www.opsrra.ca)), with the addition of information regarding Jordan River. New maps were added and work is ongoing.
4. Maintained 27 Community Notice boards in Otter Point, plus the 2 Welcome to Shirley and 3 Welcome to Otter Point signs. Continued to maintain plantings at the bases of the signs.

5. Conducted on-line surveys on JdFEA Governance and the OPSRRA Newsletter and prepared reports on the outcomes of some of the surveys for elected representatives and JDFEA Planning Services.
6. Welcomed the residents and ratepayers of Jordan River as full members of OPSRRA following the changes to the OPSRRA Bylaws in April 2013.
7. Directors met with the candidates for the Juan de Fuca riding prior to the May 2013 provincial election to review local concerns. Questions included JdFEA governance, concerns with Highway 14, local land use planning and water issues.
8. Directors attended meetings of the Shirley/Jordan River OCP review committee and prepared a submission emphasizing the protection of groundwater and the environment.
9. Continued to report on the progress of the JdF Services Building.
10. Sponsored a public Town Hall meeting attended by local area elected representatives.
11. Queried BC Hydro regarding the number of power outages experienced over the previous year and reported to members.
12. Queried CRD Water Services regarding a potential increase in cost for water delivery as well as the proposal to close the Leech Lake watershed area.
13. Attended meetings of the JdFEA Land Use Committee, Advisory Planning Commissions, Agricultural Advisory Planning Commission, Parks & Recreation Commission, Sooke Region Museum, Economic Development Commission, Kemp Lake Waterworks District, Shirley Fire Commission and the Otter Point Fire Commission.
14. In partnership with the JdF Community Trails Society, OPSRRA presented a 1935-era map of "Sooke Bay" which shows much of what is now Otter Point and Shirley to the JdFEA to recognize the opening of the new JdF Services Building.
15. Worked on a change to the OPSRRA constitution.
16. Finalized a new logo for OPSRRA
17. Created a Face book page for OPSRRA

### 3. SURVEY RESULTS: MEDICAL MARIJUANA FACILITIES






### Medical Marijuana Survey Summary based on 29 responses


Where do you live?




Do you agree that medical marijuana facilities should be located in the Juan de Fuca Electoral Area?



Should medical marijuana facilities be classified as intensive agriculture?





Where would you support the location of medical marijuana facilities in the JDFEA?





**What setbacks would you support on land in the Agricultural Land Reserve (ALR)?**





**Should medical marijuana facilities be located on land zoned Rural?**

## OPSRRRA Medical Marijuana Survey Comments

**Do you agree that medical marijuana facilities should be located in the Juan de Fuca Electoral Area?**

### **Otter Point**

- OK if confined to indoor grow-ops.
- I believe medical marijuana facilities should only be located in areas which have sewers. Marijuana is heavily treated with chemicals which could be damaging to our ground water. That doesn't apply to any area in the Juan de Fuca. There are many areas in BC or even in Canada which would be more suitable.
- It should be considered industrial and should NOT be allowed on agricultural or residential land.
- but only on industrial zoned land not rural, ALR
- M M Facilities, because they are intense farming, will pay almost no taxes. That means that the rest of [JDFEA] will be subsidising the facilities to cover fire protection and policing, they will pay no school or road tax. Even if the facility is in the industrial park, it still will pay almost no taxes! I do not think it is fair that all the other companies in the industrial park pay there [sic] fair share of taxes, and will have to help subsidise a grow op.

This is one sweet deal for whoever gets a licence to have a grow ops [sic].

### **Shirley**

- I believe if there must be such a facility it should be in an industrial area. I am soooooooooo sick of breathing pot smoke when my neighbours vent there [sic] facilities on a daily basis.

### **Jordan River**

## **What should be the minimum setbacks?**

### **Otter Point**

- Each property should be considered in its own right as setbacks are too limiting and do not necessarily ensure a secure environment.
- Setbacks should be the same as any other industrial enterprise.
- 30 metres all around would be prohibitive on a smaller parcel.

- I am more than 90 metres from a grow- op now and the stench when venting carries for more than 90 metres so bad I go inside the house to avoid the smell neighbours driving by often ask where the smell comes from permeating inside their cars, even a 3 year old asks his mom what the smell is.

**Shirley**

- I don't know enough about this issue to feel I can have an informed opinion. As I understand it there is a project hopefully planned for the industrial park in Otter Point. This seems an appropriate place. I don't see that it needs agricultural land at all.
- I do not believe these operations should be located on agricultural land. Plants being grown inside buildings do not need to be on farm land, they should be located elsewhere. Even use of the word "facility" shows it is not farming, it is not called a medical marijuana farm.

**Jordan River**

No responses

**Where would you support the location of medical marijuana facilities in the JDFEA?**

**Otter Point**

- Most definitely NOT within the ALR.
- Since I expect that the federal government will require that the growing be done in a building rather than in a field I don't see what difference it makes.
- Put them on federal land or on military bases.
- I think there will be people applying for small grow-ops so they could be done indoors or on smaller land plots.

**Shirley**

- Medical marijuana production is a commercial manufacturing operation, NOT farming. It is done in an enclosed building and does need to use the sun nor the soil to grow. It is all done by artificial light and raised beds. Having this type of operation on on ALR or agricultural zoned land is a total waste of our very limited amounts of land which have good soil for field crops. It is similar to hothouse vegetable growing which again should not be put on agricultural land. Agricultural land should be limited to uses which require outdoor soil and sunshine and rain.
- since the facilities are highly regulated about how they can operate; and are in concrete and steel bunkers it is an industrial use of land and should only be on land zoned for industrial land use; these facilities should never be considered to be rural or farm use.

**Jordan River**

No responses

**Do you have any further comment about setbacks?**

**Otter Point**

- Setbacks are ridiculous and have no bearing on security or anything else for that matter. If a

property is appropriate for this purpose then it should be allowed. Why have a setback at all?

- I do NOT support any such facilities within the ALR.
- 30 meters all around
- I do not believe that we should use ALR land for this purpose.

**Shirley**

- read my above comments those setbacks are not far enough away from property lines.

**Jordan River**

**Further comments**

**Otter Point**

- If you advertise the location of facilities then the security is compromised.
- This is a ridiculous question! ALL activities within a community should be public knowledge. This is not the USSR!!
- I put down # 1 above , but I wish you had a zero!
- I think before they issue licences all neighbouring properties should have a vote or say on the grow-op and if they do not comply with strict emission standards they should be shut down immediately.
- Thank you for doing a survey on this topic. I am very much in support of this type of facility being located in our community.

**Shirley**

- As these manufacturing operations are conducted in "bunkers" it is pretty obvious what is happening...it is much better to be open and above board with information.
- we live in a free and democratic society and it's citizens have the right to know what is taking place in our neighbourhoods; we know about prisons and detention facilities why not MMFs?

**Jordan River**

#### **4. DUMPING IN OUR COMMUNITY**

We are going to start a map of local dumping "Hot Spots" in Otter Point, Shirley and Jordan River, (as suggested by a member at our March 23, 2014 AGM) to

record local sites, which will be useful when going to local agencies and stakeholders to help address the problem.

Watch for a dumping survey in the OPSRRA newsletter in the coming months.

Regarding the Otter Point site that is close to DeMamiel Creek: the property owner (TimberWest) is following up on dumping at that location, and is looking at moving the gate. No news yet as to the clean-up of the site.

Shakie's Drive-In, in Jordan River, was owned by Les Wade who had operated a local cedar shake mill at the top of the hill on the Shirley side of Jordan River, thus the name for his drive-in. He opened the popular location on the site of a former Shell gas station in response to the increased tourism coming to the area. It remained a popular spot to eat for surfers, campers, local residents and travellers on the road to Port Renfrew until 2012.

## 9. GOVERNANCE SERIES: JDFEA 2014 BUDGET

This is the fourth in a series on governance in the Juan de Fuca Electoral Area (JDFEA) leading-up to elections in November, 2014 for JDFEA Regional Director and School District #62 (Sooke) School Trustees and appointees to the JDFEA Land Use Committee and Advisory Planning Commissions.

To date we have looked at:

- The differences between the JDFEA Parks & Recreation Commission and SEAPARC. (January, 2014);
- Elected and appointed commissions and committees in the JDFEA. (February, 2014);

- The role and responsibilities of the JDFEA Regional Director. (March, 2014).

Next month's feature on governance in the JDFEA will look at how land use decisions are made.

### **This month's installment: property taxes.**

Property owners in the Juan de Fuca Electoral Area (JDFEA) received their 2013 property assessment from the B.C. Assessment Authority in January, 2014. Various taxing authorities use these valuations to determine individual property taxes due July 1, 2014.

Because the JDFEA is unincorporated, the province collects property taxes from us on behalf of the province, the Electoral Area, the Capital Regional District (CRD) and Sooke School District #62.

The JDFEA Regional Director has the responsibility to work with CRD Financial Services to oversee the budget for taxable items directly attributed to the JDFEA. This portion of the budget is then reviewed by the Electoral Area Services Committee of the CRD Board of Directors before being approved by the full CRD Board.

In 2011, OPSRRA encouraged our Regional Director, Mike Hicks, to post budget information to the JDFEA web site. OPSRRA also helped to draft the detailed explanation of the JDFEA budget process which is available at:

Director Hicks now prepares an annual tax report for the JDFEA showing what services you are taxed for and at what rate per \$100,000 of assessed property value. This information is available at: [Tax Report](#). The following is an excerpt from the Tax Report showing the 2014 draft budget:

The Tax Report on the JDFEA web site will be updated later in April, once the 2014 EA's budget is approved by the CRD Board of Directors.

**Note:** The province and the CRD determine their portions of the property tax using a separate process which is beyond the direct control of the

JDFEA Regional Director. The budget for SD #62 is also determined by the province.

Director Hicks provided the OPSRRA newsletter with the following *comparisons* of 2013 property taxes in each area of the JDFEA. These figures are from the 2013 Tax Rate bylaws and to his knowledge include everything except school, water, sewer and garbage taxes.

## **10. JORDAN RIVER FEDERAL ELECTORAL BOUNDARY CHANGE**

The community of Jordan River will be split in half as the result of a recently approved change to federal riding election boundaries.

Every 10 years there is a redistribution of Canada's federal election boundaries, based upon population shift and growth identified in the federal census. An election boundary commission in each province recommends changes to a national boundary commission, which then recommends changes to Parliament. As a result, the present *Esquimalt–Juan de Fuca* riding will disappear and parts will be redistributed to two new ridings: *Saanich–Esquimalt–Juan de Fuca* and *Cowichan–Malahat–Langford*. The dividing line between the two new ridings in our area is River Jordan. Therefore, East Sooke, Sooke, Otter Point, Shirley and that part of Jordan River on the east side of the river will be in the new *Saanich – Esquimalt–Juan de Fuca* riding and that part of Jordan River on the west side of the river, as well as the Rural Resource Lands and Port Renfrew will be in the new *Cowichan–Malahat–Langford* riding.

A federal election is anticipated in 2016.

## **11. UPDATE: OTTER POINT OCP REVIEW**

The Otter Point official Community Plan (OCP) review, which began in October 2000, moved step further towards completion on March 25, 2014. A Juan de Fuca Electoral Area Planning services staff report requesting the Capital Regional Board's determination on consistency of the proposed OCP with the CRD's Regional Growth Strategy was considered at the CRD's Planning, Transportation & Protective Services Committee March 25, 2014 meeting. The committee moved the staff recommendation as follows:

That the Planning, Transportation & Protective Services Committee recommend to the Capital Regional District Board:

That the proposed Otter Point Official Community Plan (Bylaw No. 3819) be reviewed as it relates to the Regional Growth Strategy and deemed consistent with the Regional Growth Strategy.

There were no questions and the motion passed unopposed.

The OCP should be considered by the full CRD Board at their April 9, 2014 meeting. Confirm the agenda for that meeting on Monday, April 7, 2014, by following this link:

The Shirley/Jordan River Official Community Plan (OCP) Citizens' Committee met at 7:00 pm on Wednesday, March 26, 2014. Eight of ten committee members attended, as well as two staff and three public members.

This was a working session for the Citizens' Committee; CRD staff guided the group through Resource Themes of agriculture and forestry. They looked at the goals, objectives, policies and development permit areas in these sections that CRD staff reworked from the old OCP to try to align the information and values that were identified by the committee and members of the public during the Open House held in Shirley January 26, 2014.

There is a special meeting to review the draft of the Sensitive Ecosystems Inventory (SEI) scheduled for 7:00 pm on Wednesday, April 9, 2014, at the Juan de Fuca Local Area Services Building, 3-7450 Butler Road (note location).

## 15. DID YOU KNOW THAT ...

**By the 1890s all of the property that we now know as Otter Point was pre-empted by as few as a dozen individuals?** Pre-emption refers to the occupation of government land for settlement and agriculture; it began in British Columbia in 1850 and lasted until 1970. Someone pre-empting crown land had to meet certain provincial requirements such as surveying the property, making improvements and establishing residency. Once these conditions were satisfied the individual could purchase the land at a discount or be even given it for free. If the owner defaulted on their taxes the land reverted to the crown.


One of the first settlers to pre-empt land in Otter Point was Arthur Herewarde Floyer. We know a little about him. He was born in Martin, Lincolnshire, England in June, 1857 to Wadham J. Floyer and Augusta Gilliat. He came to East Sooke in the early 1880s and shared a building there with four former English schoolmates—Jack Gordon, Ted Gordon, Joseph Dales and Jack Dales. All bachelors, the building they lived in was called Buckingham Place and eventually became part of the Seagirt resort. Ted Gordon bought the Tugwell farm at Gordon's Beach and married Kitty Gilland, and Arthur joined Ted as a partner at the now renamed Gordon farm. There is also mention of him driving stage coach to Victoria.

It's unknown whether Arthur Floyer stayed on the property, but in about 1908 he formed a partnership with a Major Percy Byng Hall (ret'd) from Victoria and together they sold real estate and insurance, specializing in property at Port Edward, south of the Skeena River in northwestern BC.

Arthur Floyer passed away in Sooke on March 5, 1933 at the age of 76.

A First Settlers map, thought to date from 1894, shows Arthur Floyer having pre-empted

all of Section 37 (130 acres) and part of Section 36 (57 acres) immediately north of the Gordon farm. Section 37 straddles Otter Point Road just west of present day King Road and is now provincial Crown land. Section 36 is a private managed forest that adjoins the "Admiral's Forest".
